### **PRIVACY POLICY**

We respect and are committed to protecting your privacy. We may collect personally identifiable information when you visit our site. We also automatically receive and record information on our server logs from your browser including your IP address, cookie information and the page(s) you visited. With the exception of our authorized & registered tradeshow exhibitors, your information will be kept confidential & will not be shared. ### **SECURITY POLICY**

Any refund amount will be subject to a \$50 administrative fee, which will be deducted from the refund. No refunds will be given after the June 8, 2017 deadline.
